P1.21 APPOINTMENT OF CHAIR/VICE CHAIR

P6.21 MINUTES

P7.21 APPLICATIONS

- (a) Application No. WD/D/20/003210 Merianda House, The Street
 Alterations to fenestration and infill covered entrance The Parish Council has no objections in principle but as the property is in the Conservation Area, the success of the proposal should depend on the quality and colour of materials used on the frontage.
- (b) Application No. WD/D/20/003206 Beach Access South of Heritage Coast Centre, Lower Sea Lane Beach access ramp No comment as Parish Council's own application.
- (c) Application No. WD/D/20/002875 Land South of Nutcombe Close Erection of 1 No. dwelling

(Letter circulated from applicants) – The Parish Council has no objections in principle to this application but would like to see a condition that precludes the garages from being used as residential accommodation.

- (d) Application No. WD/D/20/003126 Manor Farm Holiday Centre, The Street

 Demolition of toilet block and formation of two new bases for static caravans The Parish Council has no objections in principle to this application but would comment as follows:
 - The application indicates that surface water is to soakaways, it would be preferred if this were connected to the drainage system;
 - The plan shows a water pump in close proximity to the new slabs but no clarification as to what this is for;
 - It is assumed that the removal of this toilet block leaves adequate toilet facilities in the area.

P10.21 NEIGHBOURHOOD PLAN STEERING GROUP

- (a) Update from NHP Steering Group Andy Bateman reported that, since September, the presubmission comments have been looked at and following research on some issues raised by certain parties the consultation summary (50 pages) had now been completed. Depending on feed back from DC re compliance with policies and from Jo Witherden regarding the revision of the "Basic Condition Statement", the consultation summary should be with the Parish Council shortly. Andy stated that the 22 policies are the most important part of the huge amount of information for the Parish Council to review and approve.
- (b) NHP Pre-submission Consultation Table comments from Residents/Local Businesses Should the Yew Trees in the front churchyard be given TPOs? It was generally felt by the Committee that these ancient specimens should be protected but before a proposal is made to Full Council, the views of the Vicar and Changing Spaces would be sought.
